All registered crafters are expected to comply with the below stated rules. Failure to comply will result in you being asked to leave and no further invitations to our show.

The hours of our Craft Show are 8:00 AM to 6:30 PM. Setup will start at 6:30 a.m. the morning of the event. Vendors must be ready no later than 8 a.m. Volunteers will be on hand to assist with loading and unloading. There will be no tearing down of displays before the 6:30 PM end of show.

For an additional \$25, Easterseals will list a link to your business on our Volleyball page, visited by all teams, players, sponsors and volunteers.

APPLICATIONS AND PAYMENTS RECEIVED VIA USPS MAIL ARE DATE STAMPED UPON RECEIPT. **ONLY RECEIPT OF PAYMENT COMPLETES REGISTRATION.**

Please note that this event is based on a first-come, first-serve basis. Only 1 vendor will be scheduled for each product (i.e. first Avon representative to submit fully completed paperwork AND payment will get a space).

Vendors whose payment was received and who will not be accommodated in the vendor fair will be advised via email, checks will be voided and shredded. Verifications of voided check with removal of account number will be provided as well.

All vendors must sign the Waiver of Release and Liability below.

Upon entering the Vendor Fair area, each guest will be given a map of vendor areas and an "I've Seen It All" page to receive 5 colored stamps from various vendors. If guests collect 5 colored stamps

and return the completed map to the raffle area at the end of their visit (located in the venue main entrance lobby), they will be given a ticket for a chance to win one of our exciting raffle items. This will encourage guests to visit a variety of spaces for maximum vendor exposure. We will supply everything you need. No unaccompanied children may receive a “stamp”; an adult must be present.
